- If you would like to borrow a rod, participants will be required to go through the California Department of Fish and Wildlife Learning Stations. All gear must be returned before lunch. A limited amount of gear will be available to borrow.

Parking

- Clarion Drive between Juanita Place and Lakeview Drive will be closed to thru traffic from 6:30am-1:00pm. Limited parking is available in the Fullerton Recreational Rider area next to Laguna Lake, parking is also available at the Sunny Hills Church of Christ parking lot at 2255 N. Euclid St. You may also park off Terraza PI, Clarion Drive above Juanita PI and surrounding public streets (there is no parking on Lakeview Dr. between Clarion Dr. and Hermosa Dr.)

A "Drop off" area will be available near Lakeview Dr and Clarion Dr, however it is highly recommended that you arrive early and carpool if possible.

 rod in the water. Children are allowed to only use one rod. (this is a children's event)
- There is a 2 fish limit per child. All bass and catfish must be at least 12 inches in size to keep. Although we do encourage catch and release.

Lunch & Raffle: (11:30 - 12:30)

- Lunch will be available for purchase from 11:30 12:15. <u>The Izaak Walton League</u> will be selling hot dogs, snacks and drink for \$1.00. We will also be selling popsicles and ice cream from a separate vendor for a nominal fee.

The lake will be closed for fishing to the public Friday, April 12, 2013.

Upon completion of the event at 12:30, the lake will be open to the public. Please be aware that <u>anyone 16 and over must have a fishing license on display</u> (around neck or pinned to clothing) in order to fish after the derby. The Department of Fish and Wildlife will be on-hand to monitor this policy. Citations will be issued. The take limit at Laguna Lake is **two fish per person per day**.
