## RESOLUTION NO. 8749

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF FULLERTON ESTABLISHING TERM LIMITS FOR MEMBERS OF CERTAIN CITY COMMITTEES AND AMENDING RESOLUTIONS NOS. 8366, 6951, 7488 AND 6755 ACCORDINGLY

WHEREAS, the City of Fullerton has various commissions, committees, authorities, ta forces and boards (hereinafter referred to as Commissions) whose members serve differiterms.

WHEREAS, it is the desire of the City Council that the length of term for members of Commissions, except the Board of Library Trustees, be the same.

WHEREAS, by Ordinance, the City Council has established four-year terms a conditions governing reappointment.

WHEREAS, it is necessary to amend the resolutions of certain advisory bodies and pr minute actions to conform with said Ordinance.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Fullerton that

- 1. That the term of office for members of the Community Development Citize Committee, established at three years by Council action on September 15, 1981, is here amended to four years.
- 2. That the fourth sentence of Section 3 of Resolution No. 8366 pertaining to t Bicycle Users Subcommittee is hereby amended to read: "The term of office for members shoe three years four years."
- 3. That Section 5 of Resolution No. 6951 pertaining to the Airport Noise & Safe Committee is hereby amended to read: "Thereafter, all subsequent appointments shall be two-year periods four-year periods."
- 4. That Section 4 of Resolution No. 7488 pertaining to the Airport Users Task Force hereby amended to read: "Appointments shall be made for a period of two years four year Members number 1, 3, 5 and 9 shall be appointed on every-odd numbered years and member number 2, 4, 6 and 8 shall be appointed on every-even numbered years.
- 5. That the first sentence of Section 5 of Resolution No. 6755 pertaining to the Ener & Resource Management Committee is hereby amended to read: "The term of office of a-ini Committee members shall be for three years"; and the last sentence thereof is hereby amend to read: "All subsequent Committee Members shall be appointed by City Council to serve three year terms four-year terms.
- 6. That the term of office for members of the Investment Committee, as contained Section 13 of the City's Investment Policy, adopted by Council on July 5, 1995, is here amended from "three-years" to "four years".
- 7. That a four-year term of office is hereby established for members of the Afforda Housing Review Committee.
