Qualifying User Groups in Descending Order of Priority

City Council, City departments, other county, state, federal, and municipal governments that conduct activities may be charged a use fee, a fee for lights, and may be charged for staff time which shall be determined on a case-by-case basis by the Director of Parks and Recreation.

- <u>Group 1</u> Fullerton-based: elementary schools, nonprofit* service and recreation-based** athletic organizations that conduct youth community service activities, programs, and athletic events which are open to the general public and are not fund-raising events.*** Proof of insurance may be required.
- <u>Group 2</u> Fullerton-based: public high schools, community colleges, and public universities that conduct community service activities, programs and athletic events are open to the public and are not fund-raising events.*** Proof of insurance may be required.
- Group 3 Fullerton residents: Proof of residency will be required.****
- <u>Group 4</u> Fullerton-based: private schools, private universities and nonprofit* competition-based** athletic organizations that conduct community service activities, programs and athletic events which are open to the public and are not fund-raising events***. Proof of insurance may be required.
- <u>Group 5</u> Fullerton-based: commercial, business, religious, political groups and professional firms that conduct events and activities which are not open to the general public and are not profit-oriented. Groups 1 and 2 conducting fund-raising events***.
- <u>Group 6</u> Non-Fullerton: nonprofit* civic, service, and religious groups and individuals that conduct events that are not profit-oriented. Group 4 conducting fund-raising events***. Proof of insurance may be required.
- <u>Group 7</u> Non-Fullerton: commercial, business, professional firms and political groups, for events that are not profit-oriented per Fullerton Municipal Code 9.12.460***. Proof of insurance may be required.
- *The Parks and Recreation Department may request verification of a State of California Nonprofit Corporation status and/or Internal Revenue Profit Exemption certificate to substantiate status as a Fullerton-based organization, or, in the case of Independence Park use, as an Orange County-based organization. An organization will be considered a Fullerton-based and Orange County-based organization if its membership includes 80 percent residents from Fullerton and Orange County respectively.
- **Recreation-based athletic leagues teach fundamental skill development, sportsmanship, teamwork, and physical fitness. Playing time is distributed equally among the players. Competition-based athletic leagues (commonly referred to as travel and club teams) teach advanced and specialized skills and travel outside the City to play other advanced teams. Playing time is based on skill level and is not guaranteed.
- ***Fees for profit-oriented or fund-raising activities shall be determined on a case-by-case basis by the Director of Parks and Recreation.

^{**}Deposit refundable if the facility is left in good condition.

^{****}Applicants will be required to submit proof of qualifying residency. A temporary driver's license will not be accepted for this purpose unless accompanied by other proof of residency, as may be requested by the Parks and Recreation Department. In the case of wedding or anniversary receptions, the bride, groom, or a member of the immediate family must be a resident of Fullerton to qualify for use of City parks under Group 3.
