A detailed project description was previously provided in Section 3. In summary, the proposed project involves the demolition of the existing buildings and above-grade associated facilities onsite. The existing paved surfaces would remain; no grading or excavation activities would occur.
9. Surrounding land uses and setting: Briefly describe the project's surroundings:

NORTH: Land uses to the north include industrial, commercial (restaurant/bars and nightclubs) and residential uses, along Santa Fe Avenue.

SOUTH: Land uses to the south include the BN&SF railroad tracks, industrial, and commercial uses. Residential uses are located farther to the south.

EAST: Land uses adjacent to project site to the east include vacant industrial also associated with the former World Citrus facility. Land uses further to the east across Harbor Boulevard include the Fullerton Transportation Center and the Santa Fe Train Depot as well as retail/commercial uses.

WEST: Land uses to the west include industrial and commercial uses and Amerige Park (across Highland Avenue).


